- **Please Note: We are unable to process any payments over the phone. If you send us an email authorizing us to charge your credit card, we will gladly do so.**

**RE-LISTING FEE:**

- If your auction purchases are not paid for by the specified deadline the credit card on file will be charged a re-listing fee of 10% of the total bid price(s), or \$10, whichever is greater (not to exceed \$100). Those individuals not paying will not be permitted to participate in future auctions.

**REMOVAL:** All items must be removed at buyers expense and responsibility on October 18th and 19th from 8:15am - 4:45pm.
